# **Grass Roots Nursery Group: Intimate Care Routines Policy**

# Purpose:

To ensure that children receive consistent, compassionate, and safe care during intimate care routines, such as nappy changing, toileting, and clothing changes.

# **Key Principles:**

- Consistent Care: Children will be cared for primarily by their assigned key person, fostering a sense of familiarity and trust.
- **Safety and Welfare:** We prioritise the safety and well-being of children during all care routines, adhering to strict hygiene and safety protocols.
- **Privacy and Dignity:** We respect children's privacy and dignity, ensuring that intimate care is conducted in a private and respectful manner.
- **Parent Partnership:** We work closely with parents/carers to understand and meet children's individual needs, fostering open communication and collaboration.

#### **Procedures:**

#### **Staff Qualifications and Training:**

- All staff involved in intimate care routines must have undergone appropriate training, including:
  - First aid training
  - Child safeguarding training
  - Infection control training
  - Specific training on intimate care procedures
- Staff must also have a valid enhanced DBS check.

### Safe Practices:

- Hygiene: Staff must adhere to strict hygiene practices, including wearing gloves and aprons during intimate care routines.
- Equipment: We use clean, sanitised equipment, such as changing mats and wipes.
- Waste Disposal: Waste from intimate care routines is disposed of appropriately in sealed bags.
- Infection Control: We follow infection control guidelines to prevent the spread of germs.

#### **Privacy and Dignity:**

- Intimate care routines are conducted in private areas, away from other children.
- Staff use gentle and respectful language and approach children with sensitivity.
- We respect children's bodily autonomy and avoid rushing or forcing them during care routines.

#### **Parent Communication:**

- We maintain open communication with parents/carers regarding their child's care needs, including any specific preferences or concerns related to intimate care.
- We encourage parents to discuss any changes in their child's needs or routines.
- We provide parents with information about our intimate care procedures and policies.



# **Monitoring and Review:**

- We regularly monitor staff practices to ensure compliance with our policies and procedures.
- We conduct supervision meetings and appraisals to identify any areas for improvement and provide additional training if needed.
- This policy is reviewed annually to ensure its effectiveness and alignment with current best practices.

#### **Specific Routines:**

#### **Nappy Changing:**

- Nappies are changed frequently, according to the child's individual needs.
- Staff use a clean changing mat and wear gloves and an apron.
- Nappy waste is disposed of in sealed bags.
- Staff check for diaper rash and apply appropriate cream as needed.

#### **Toileting:**

- We support children in developing toilet training skills at their own pace.
- We provide appropriate toileting facilities, including low-level toilets and potties.
- Staff assist children with toileting as needed, ensuring privacy and dignity.
- We encourage children to wash their hands after using the toilet.

# **Clothing Changes:**

- We assist children with changing clothes as needed, ensuring privacy and comfort.
- We respect children's preferences for clothing and encourage them to dress themselves independently when appropriate.
- We soiled clothing is bagged appropriately and sent home on the same day.

#### Safeguarding:

- We adhere to our Safeguarding and Child Protection Policy to ensure children's safety.
- Staff are trained to identify and report any concerns about a child's well-being, including signs of abuse or neglect.
- We have a whistleblowing policy in place to encourage staff to raise any concerns about potential safeguarding issues.

By following these procedures, we aim to provide a safe, caring, and respectful environment for children during intimate care routines.



# **Procedure for Intimate Care Routines**

#### **Purpose:**

To outline the specific steps to be followed by staff members when conducting intimate care routines, such as nappy changing, toileting, and clothing changes.

#### **Procedure:**

# **Before Care:**
